**Hazard : COVID-19 TRANSMISSION GENERAL STRATEGY** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. PEOPLE WILL NOT BE PERMITTED TO ENTER THE SITE WHO HAVE COVID-19 SYMPTOMS SUCH AS A NEW COUGH, HIGH TEMP OR ANOSMIA
2. TEMPERATURE SCREENING FOR EVERYBODY WHO ENTERS SITE, ACCESS DENIED FOR THOSE WITH A HIGH TEMPERATURE
3. ENSURE THOSE ENTERING THE SITE MAINTAIN CLEAN HANDS, BY PROVIDING GUIDANCE ON HANDWASHING AND PROVIDING ADDITIONAL HAND SANITISER DISPENSERS AT KEY LOCATIONS AROUND THE FACILITY
4. INCREASED CLEANING AND DISINFECTION OF OBJECTS AND SURFACES THAT ARE TOUCHED REGULARLY AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT WHICH MEETS BS EN14476 WILL TAKE PLACE
5. FACILITY ANNOUNCEMENTS REMINDING PEOPLE TO WASH OR SANITISE THEIR HANDS, KEEP TWO METERS APART AND CLEAN AS THEY USE # CLEANING IS THE NEW COOL DOWN
6. ADDITIONAL CLEANING STATIONS PROVIDED AT KEY LOCATIONS AROUND THE FACILITY TO PROMOTE A CLEAN AS YOU USE MESSAGE
7. A SUITE OF SIGNAGE WILL BE IN PLACE TO PROMOTE PHYSICAL DISTANCING AND ENSURING THE SITE EQUIPMENT IS SPACED OUT TO FACILITATE THIS
8. ALL MEMBERS WILL SIGN IN (WRISTBAND) & ALL STAFF WILL BE RECORDED VIA DEPUTY. ALL OTHER PEOPLE (INCLUDING THIRD PARTY STAFF) WILL BE RECORDED VIA VISITORS BK, (NAME PHONE NO, TIME IN/OUT) IN ORDER TO COMPLY WITH NHS TRACING REQUIREMENTS.
9. THE FACILITY WILL REMAIN WELL VENTILATED TO REDUCE THE TRANSMISSION RISK EVEN FURTHER, THE VENTILATION SYSTEM WILL OPERATE DRAWING IN AS MUCH FRESH AIR AS ALLOWS.
10. THE NUMBER OF PEOPLE USING THE FACILITY WILL BE REDUCED TO SOCIAL DISTANCING AND REDUCE THE RISK OF POSSIBLE TRANSMISSION
11. ANY D6 ADVERTISING SCREENS WILL SHOW MEDIA REMINDING USERS OF THE COVID-19 TRANSMISSION REDUCTION STRATEGY
12. A FACE COVERING MUST BE WORN BY ALL THOSE ENTERING THE FACILITY AND IN ALL INDOOR AREAS (EXCEPT WHEN EXERCISING/UNDERTAKING PHYSICAL ACTIVITY OR WHEN SEATED AT A TABLE AND CONSUMING FOOD AND/OR DRINK)
13. THOSE WHO ARE EXEMPT FOR WEARING A FACE COVERING ARE STILL REQUIRED TO WEAR A VISOR UNDER THE TERMS OF THEIR MEMBERSHIP/PREMISE RULES.
14. THE NHS QR CODE POSTER WILL BE DISPLAYED AT THE SITE (ENGLAND/WALES ONLY)

**Hazard : COVID -19 TRANSMISSION ENTERING THE CLUB** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. ENTRY INTO THE FACILITY WILL BE SEPARATED FROM THE EXIT ROUTE OF THE FACILITY TO REDUCE RISK OF TRANSMISSION AND MAINTAIN 2 METERS SOCIAL DISTANCING

2. IF THERE IS ONLY ONE ENTRY/EXIT ROUTE INTO THE FACILITY, SIGNAGE AND FLOOR MARKINGS WILL BE IN PLACE ADVISING MEMBERS THEY MUST GIVE WAY TO THOSE EXITING AND MAINTAIN 2 METERS SCIOAL DISTANCING

3. ANY DOORS TO ENTER/EXIT THE FACILITY WHICH ARE NOT AUTOMATIC WILL BE SECURED IN AN OPEN POSITION TO AVOID ADDITIONAL TOUCH POINTS AND AID VENTILATION

4. SIGNAGE WILL BE DISPLAYED IN A PROMINENT LOCATION STATING TO STAY AWAY IF:- you have been instructed to isolate or if you are displaying any of the following symptoms: you have lost your sense of taste and/or smell a continuous cough a high temperature

5. EMPLOYEES OPENING THE FACILITY WILL ARRIVE 30 MINUTES BEFORE MEMBERS ARE ALLOWED TO ENTER THE SITE

6. INCREASED DISINFECTION OF COMMON TOUCH POINTS AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT WHICH MEETS BS EN 14476 WILL TAKE PLACE

7. A FACE COVERING MUST BE WORN BY ALL THOSE ENTERING THE FACILITY AND IN ALL INDOOR AREAS (EXCEPT WHEN EXERCISING/UNDERTAKING PHYSICAL ACTIVITY) THOSE WHO ARE EXEMPT FOR WEARING A FACE COVERING ARE STILL REQUIRED TO WEAR A VISOR UNDER THE TERMS OF THEIR MEMBERSHIP.

**Hazard : COVID-19 TRANSMISSION RECEPTION** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. A LINE ONE METER AWAY FROM THE CUSTOMER FACING EDGE OF THE RECEPTION COUNTER WILL BE MARKED (ALL THE WAY AROUND THE TOTAL COUNTER)

2. A SECOND LINE WILL BE MARKED IN BEHIND THE RECEPTION COUNTER ONE METER AWAY FROM THE CUSTOMER FACING EDGE OF THE RECEPTION COUNTER (TAKING INTO ACCOUNT THE WIDTH OF THE COUNTER ITSELF)

3. A SAFE SPACE WILL BE MARKED BEHIND THE RECEPTION COUNTER WHERE THE EMPLOYEE MUST STAND IF SOMEONE IS STOOD AT THE CUSTOMER FACING EDGE OF THE RECEPTION COUNTER (FOR EXAMPLE MAKING A WRISTBAND PAYMENT) THIS WILL ENSURE 2 METERS IS MAINTAINED

4. NO CASH WILL BE HANDLED PAYMENTS USING CARDS OR WRIST BAND WILL ONLY BE ACCEPTED

5. INCREASED DISINFECTION OF COMMON TOUCH POINTS AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN14476 WILL TAKE PLACE

6. REMOVE THE VISITOR BOOK FROM THE RECEPTION COUNTER, THE VISIT WILL BE RECORDED BY THE EMPLOYEE ON THE VISITORS BEHALF. ALL VISITORS MUST BE TEMPERATURE SCREENED AND THEIR VISIT RECORDED (NAME, PHONE NO & TIME IN/OUT) TO COMPLY WITH NHS TRACING REQUIREMENTS (INCLUDING 3RD PARTY STAFF)

7. COMPETENT AND TRAINED EMPLOYEES SHOULD COMPLETE THE PERMISSION TO WORK ON BEHALF ON THE CONTRACTOR. THE CONTRACTOR WILL BE REQUIRED TO COMPLETE A PERMIT TO WORK & SIGN USING THEIR OWN PEN, AFTER EXCHANGE OF THIS DOCUMENT THE EMPLOYEES HAND MUST BE WASHED OR SANITISED.

8. EMPLOYEES WILL WASH THEIR HANDS WITH SOAP AND WATER FOR AT LEAST 20 SECONDS AT THE NEAREST WASH HAND BASIN FREQUENTLY THROUGHOUT THE DAY
9. A BRAKES HARD SURFACE SANITISER IN A TRIGGER BOTTLE AND PAPER TOWEL WILL BE READILY AVAILABLE BEHIND RECEPTION TO FACILITATE EXTRA CLEANING
10. SIGNAGE WILL BE IN PLACE REMINDING PEOPLE NOT TO CROSS THE LINE UNLESS DIRECTED TO DO SO BY AN EMPLOYEE AND NOT BEFORE THE EMPLOYEE MOVES TO THEIR SAFE SPACE
11. EMPLOYEES WILL ADHERE TO THE CLEAN AS YOU USE SYSTEM, CLEANING EQUIPMENT BEFORE AND AFTER USE
12. ANYONE HANDLING USED TOWELS MUST WEAR LEVEL 2 PPE
13. ANY MEMBERS WHO CANNOT SWIPE IN WITH THEIR WRIST BAND WILL HAVE A MANUAL GATE ENTRY RECORDED IN ORDER TO COMPLY WITH NHS TRACING REQUIREMENTS

**Hazard : COVID-19 TRANSMISSION FOYER AREA** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. TEMPERATURE SCREENING FOR ANYONE ENTERING THE CLUB WILL BE UNDERTAKEN, ANYONE WITH A HIGH TEMPERATURE INITIALLY AND AFTER THE REPEAT TEST WILL BE DENIED ACCESS A LETTER OF DENIAL WILL BE ISSUED.
2. A HAND SANITISER DISPENSER POINT WILL BE PROVIDED BEFORE ENTRY INTO CLUB (TURNSTILES) EVERYONE MUST SANITISE THEIR HANDS BEFORE PASSING THROUGH THE TURNSTILES, SIGNAGE ON HOW TO USE THE SANITISER WILL BE IN PLACE.
3. SIGNAGE WILL BE IN PLACE REMINDING THOSE WITH SYMPTOMS NOT TO USE FACILITY. SIGNAGE AND/OR FLOOR MARKERS WILL BE IN PLACE TO REMIND PEOPLE TO KEEP 2 METERS APART
4. ALL PEOPLE VISITING THE SITE WILL BE RECORDED IN THE VISITOR BOOK AND DETAILS RETAINED IN ORDER TO COMPLY WITH NHS TRACING REQUIREMENTS
5. INCREASED DISINFECTION OF COMMON TOUCH POINTS AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT WHICH MEETS BS EN14476 WILL TAKE PLACE
6. ANY FACILITIES WITH AN ENTRANCE PRIOR TO THE TURNSTILE WILL HAVE AN ADDITIONAL WALL MOUNTED HAND SANITISER IN PLACE.
7. A FACE COVERING MUST BE WORN IN ALL INDOOR AREAS (EXCEPT WHEN EXERCISING/UNDERTAKING PHYSICAL ACTIVITY) THOSE WHO ARE EXEMPT FROM WEARING FACE COVERING ARE STILL REQUIRED TO WEAR A VISOR UNDER THE TERMS OF THEIR MEMBERSHIP.

**Hazard : COVID-19 TRANSMISSION CAFE BAR** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. A LINE ONE METER AWAY FROM THE CUSTOMER FACING EDGE OF THE CAFE BAR COUNTER WILL BE MARKED (ALL THE WAY AROUND THE TOTAL COUNTER)
2. A SECOND LINE WILL BE MARKED IN BEHIND THE CAFE BAR COUNTER ONE METER AWAY FROM THE CUSTOMER FACING EDGE OF THE CAFE BAR COUNTER (TAKING INTO ACCOUNT THE WIDTH OF THE COUNTER ITSELF)

3. A SAFE SPACE WILL BE MARKED BEHIND THE RECEPTION COUNTER WHERE THE EMPLOYEE MUST STAND IF SOMEONE IS STOOD AT THE CUSTOMER FACING EDGE OF THE RECEPTION COUNTER (FOR EXAMPLE MAKING A WRISTBAND PAYMENT)
4. NO CASH WILL BE HANDLED PAYMENTS USING CARDS OR WRIST BAND WILL ONLY BE ACCEPTED
5. THE AREA BEHIND THE CAFE BAR COUNTER WILL BE DIVIDED INTO ZONE SO IF THERE IS MORE THAN ONE EMPLOYEE THEY CAN MAINTAIN TWO METERS APART. THE EMPLOYEES ROLES WILL BE DIVIDED SO THEY DO NOT CROSS OVER (FOR EXAMPLE EMPLOYEE X WILL TAKE ORDERS AND PAYMENT WHILST EMPLOYEE Y PREPARES ITEM)
6. IF THERE IS MORE THAN ONE EMPLOYEE STATIONED AT THE CAFE BAR, ANY BACK OF HOUSE KITCHEN/STORAGE ZONES WILL BE ALLOCATED TO A DESIGNATED EMPLOYEE AS THEIR WORKSPACE (FOR EXAMPLE BOTH EMPLOYEES AT FRONT OF HOUSE SHOULD NOT BOTH FETCH ITEMS FROM THE STORE IT MUST BE ONE PERSONS ROLE)
7. NO NEWSPAPERS/MAGAZINES ETC WILL BE PROVIDED
8. FREQUENT DISINFECTION OF COMMON TOUCH POINTS WITH IN FOOD CATERING AREAS AT A MINIMUM OF TWO HOURLY INTERVALS WITH BRAKES HARD SURFACE SANITISER WHICH MEETS BS EN 1276 IN A TRIGGER BOTTLE AND PAPER TOWEL
9. SOAP AND PAPER TOWELS AND GUIDANCE WILL BE PROVIDED AND MAINTAINED AT ALL WASH HAND BASINS AND EMPLOYEES WILL WASH THEIR HANDS WITH SOAP AND WATER FOR AT LEAST 20 SECONDS FREQUENTLY THROUGHOUT THE DAY
10. EMPLOYEES WILL ADHERE TO THE CLEAN AS YOU USE SYSTEM FOR CLEANING EQUIPMENT AND FOOD AREAS IN CAFE BAR WITH THE BRAKES HARD SURFACE SANITISER (FOOD SAFE)
11. INCREASED DISINFECTION OF COMMON TOUCH POINTS (EXCLUDING FOOD CATERING AREAS) AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN 14476.
12. SIGNAGE WILL BE IN PLACE REMINDING PEOPLE NOT TO CROSS THE LINE UNLESS DIRECTED TO DO SO BY AN EMPLOYEE AND NOT BEFORE THE EMPLOYEE MOVES TO THEIR SAFE SPACE
13. NAMES AND CONTACT NUMBERS OF ALL VISITORS EATING AT THE FACILITIES THAT ARE NOT MEMBERS WILL BE RECORDED AND RETAINED FOR A MINIMUM OF 21 DAYS THESE WILL BE HELD IN ACCORDANCE WITH GDPR AND TO FACILITATE NHS TRACING REQUIREMENTS
14. THE CAFE BAR WILL PROVIDE TAKEAWAY FOOD AND DRINK ONLY, NO ALCOHOL WILL BE SERVED EVEN HAS A TAKEAWAY ITEM.
15. SELF SERVICE ITEMS WILL BE KEPT TO A MINIMUM
16. ASK CUSTOMERS TO AVOID WAITING AT THE COUNTER ANY QUEUES WILL BE SUBJECT TO 2 METERS SOCIAL DISTANCING
17. FOOD OR ITEMS BEING PASSED FROM THE KITCHEN TO FRONT OF HOUSE SHOULD BE PUT IN THE COLLECTION ZONE SO EMPLOYEES CAN MAINTAIN 2 METERS
18. THE FACILITY OPERATES AS A FULL CATERING SITE THEREFORE PLEASE REFER TO THE SEPARATE RA FOR THIS FACILITY
19. NO SALE OF ALCOHOL WILL NOT BE PERMITTED, ALL ALCOHOL WILL BE REMOVED FROM SALE AND ANY REFERENCE TO ALCOHOL SALES WITHDRAWN. SIGNAGE WILL BE IN PLACE IN STATING NO ALCOHOL IS BEING SOLD.
20. BACKGROUND MUSIC AND TELEVISIONS WILL BE KEPT AT A LOW VOLUME
21. ANY PLAY AREAS CONNECTED TO CAFE BARS WILL REMAIN CLOSED

**Hazard : COVID-19 TRANSMISSION OFFICES** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. OFFICES WILL BE USED BY ONE EMPLOYEE ONLY
2. IN OFFICES WITH CAPACITY TO ACCOMODATE MORE THAN ONE EMPLOYEE, THE EMPLOYEES WILL WORK FACING AWAY FROM EACH OTHER (BACK TO BACK) AND MAINTAIN 2 METERS DISTANCE
3. EMPLOYEES WILL HAVE THEIR OWN EQUIPMENT (WHERE POSSIBLE) SHARED EQUIPMENT MUST BE DISINFECTED IN BETWEEN USE
4. EMPLOYEES WILL ADHERE TO THE CLEAN AS YOU USE SYSTEM, CLEANING EQUIPMENT BEFORE AND AFTER USE (EXAMPLE TOUCH BUTTONS ON KEYBOARD OR PHOTOCOPIER)
5. BRAKES HARD SURFACE SANITISER IN A TRIGGER BOTTLE AND PAPER TOWEL WILL BE READILY AVAILABLE IN ALL OFFICE SPACES TO FACILITATE EXTRA CLEANING
6. INCREASED DISINFECTION OF COMMON TOUCH POINTS A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN14476 WILL TAKE PLACE
7. EMPLOYEES WILL WASH THEIR HANDS WITH SOAP AND WATER FOR AT LEAST 20 SECONDS AT THE NEAREST WASH HAND BASIN FREQUENTLY THROUGHOUT THE DAY

**Hazard : COVID-19 TRANSMISSION USE OF LIFT** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. SIGNAGE WILL BE IN PLACE REMINDING MEMBERS TO KEEP 2 METERS APART, THIS WILL MEAN ONLY ONE PERSON AT ONE TIME CAN USE THE LIFT
2. INCREASED DISINFECTION OF COMMON TOUCH POINTS A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN 14476 WILL TAKE PLACE

**Hazard : COVID-19 TRANSMISSION WC FACILITIES** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. SIGNAGE AND/OR FLOOR MARKERS WILL BE IN PLACE TO REMIND PEOPLE TO KEEP 2 METERS APART
2. ADEQUATE SUPPLIES OF SOAP AND PAPER TOWEL WILL BE PROVIDED AND MAINTAINED AT WASH HAND BASINS (PAPER TOWEL WHERE NO HAND DRYER IS IN PLACE)
3. INCREASED DISINFECTION OF COMMON TOUCH POINTS A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT WHICH MEETS BS EN 14476 WILL TAKE PLACE
4. SIGNAGE WILL BE IN PLACE ADVISING MEMBERS THEY MUST GIVE WAY TO THOSE EXITING THE FACILITY
5. SIGNAGE WILL BE IN PLACE TO INDICATE EFFECTIVE HAND WASHING PROCEDURES

**Hazard : COVID-19 TRANSMISSION CHANGING ROOMS** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. SIGNAGE AND/OR FLOOR MARKERS WILL BE IN PLACE TO REMIND PEOPLE TO KEEP 2 METERS APART WHERE POSSIBLE
2. LOCKER NUMBERS WILL BE REDUCED BY LOCKING OFF ALTERNATIVE LOCKERS IN ORDER TO REDUCE TOUCH POINTS, AREAS THAT NEED CLEANING AND TO ENSURE NO ONE IS DIRECTLY NEXT TO ANOTHER PERSON
3. EMPLOYEES WEARING LEVEL 2 PPE (AS STATED IN RMP) WILL UNDERTAKE CHECKS IN THE CHANGING ROOMS AREAS TO ENSURE SOCIAL DISTANCING AND OTHER RULES ARE ADHERED TO
4. INCREASED DISINFECTION OF COMMON TOUCH POINTS A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN 14476 WILL TAKE PLACE
5. SIGNAGE WILL BE IN PLACE ADVISING MEMBERS THEY MUST GIVE WAY TO THOSE EXITING THE AREA
6. A CLEANING STATION WILL BE AVAILABLE TO FACILITE THE CLEAN AS YOU USE SYSTEM
7. SHOWER NUMBERS WILL BE REDUCED BY TAKING OUT OF USE ALTERNATIVE SHOWERS TO FACILITATE EXTRA CLEANING AND REDUCE TOUCH POINTS
8. ADEQUATE SUPPLIES OF SOAP WILL BE PROVIDED AND MAINTAINED AT WASH HAND BASINS AND PAPER TOWEL WHERE NO HAND DRYER IS IN PLACE.
9. SIGNAGE WILL BE IN PLACE AT WASH HAND BASINS TO INDICATE EFFECTIVE HAND WASHING PROCEDURES
10. MEMBERS WILL BE ENCOURAGED TO ARRIVE ALREADY IN THEIR KIT SO REDUCE THE NUMBERS USING THE CHANGING ROOMS

**Hazard : COVID-19 TRANSMISSION STAFF REST AREAS** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. STAFF REST AREAS WILL BE USED BY ONE EMPLOYEE AT A TIME ONLY
2. IN AREAS WITH CAPACITY TO ACCOMODATE MORE THAN ONE EMPLOYEE, THE EMPLOYEES WILL ENSURE THEY MAINTAIN 2 METERS APART AT ALL TIMES
3. EMPLOYEES WILL ADHERE TO THE CLEAN AS YOU USE SYSTEM, CLEANING THE AREA/EQUIPMENT BEFORE AND AFTER USE
4. A BRAKES HARD SURFACE SANITISER IN A TRIGGER BOTTLE AND PAPER TOWEL WILL BE READILY AVAILABLE TO FACILITATE EXTRA CLEANING
5. SOAP AND PAPER TOWELS WILL BE PROVIDED AND MAINTAINED AT ALL SINKS IN STAFF REST AREAS

1. USED LAUNDRY WILL BE HANDLED BY EMPLOYEES IN LEVEL 2 PPE ONLY. DO NOT SHAKE USED LAUNDRY TO MINIMISE THE POSSIBILITY OF DISPERSING THE VIRUS THROUGH THE AIR
2. DISINFECT ANYTHING USED FOR TRANSPORTING LAUNDRY WITH SANOSIL VIRUCIDAL DISINFECTANT BEFORE AND AFTER USE
3. FACILITIES USING EXTERNAL LAUNDRY CONTRACTORS SHOULD LIAISE WITH THEM TO ENSURE ITEMS ARE WASHED ON THE HOTTEST SETTING POSSIBLE ABOVE 60c AND DRIED COMPLETELY OR WASHED IN A VIRUCIDAL DETERGENT WHICH MEETS BS EN 14476 AND DRIED COMPLETELY.
4. A VIRUCIDAL DETERGENT (HALO) WHICH MEETS BS EN 14476 IS IN PLACE FOR ALL INTERNAL LAUNDRIES ALL ITEMS WILL BE WASHED USING THIS PRODUCT

5. ALL ITEMS WASHED IN THE INTERNAL LAUNDRY WILL BE WASHED AT A TEMPERATURE THAT INACTIVATES COVID-19 USING THE PRE SELECTED PROGRAMME

**Control Measures:**

1. INCREASED DISINFECTION OF ALL VENDING MACHINES COMMON TOUCH POINTS AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN 14476 WILL TAKE PLACE

**Hazard : COVID-19 TRANSMISSION SUNBED ROOM** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. FACILITY CLOSED

2. INCREASED DISINFECTION OF COMMON TOUCH POINTS IN THE SUNBED FACILITY AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN 14476 WILL TAKE PLACE

3. BRAKES HARD SURFACE SANITISER AND PAPER TOWEL WILL BE AVAILABLE TO FACILITY "CLEAN AS YOU USE SYSTEM"

**Hazard : COVID-19 TRANSMISSION MEZZANINE GYM FLOOR** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. THE MEZZANINE GYM FLOOR WILL OPERATE A ONE WAY SYSTEM BEING ACCESSED ONLY BY THE REAR STAIRCASE AND LEAVING VIA THE MAIN CORE STAIRCASE

2. ANY WALKWAY ADJACENT TO EQUIPMENT MUST BE 1 METER PLUS WIDE TO ALLOW THE MEMBER TO PASS BY OTHER MEMBERS USING THE EQUIPMENT AND MAINTAIN PHYSICAL DISTANCING, THE MEMBER MUST SPEND AS SHORT AS POSSIBLE TIME IN THESE AREAS, THIS MUST BE POLICED BY EMPLOYEES

3. INCREASED DISINFECTION OF COMMON TOUCH POINTS AND EQUIPMENT AT A MINIMUM OF TWO HOURLY INTERVALS WITH A VIRUCIDAL DISINFECTANT SANOSIL WHICH MEETS BS EN 14476 WILL TAKE PLACE

4. THE MAXIMUM CAPACITY OF THE MEZZANINE FLOOR WILL BE REDUCED TO FACILITATE SOCIAL DISTANCING. ALTERNATIVE PIECES OF CV EQUIPMENT MUST BE TAKEN OUT OF USE (UNLESS FURTHER THAN 2 M AWAY FROM OTHER PIECES OF KIT). USE SIGNAGE/ UN-PLUG THE MACHINE THAT ARE NOT AVAILABLE SO IT IS CLEAR IT IS NOT IN USE

5. VENTILATION WILL BE MAINTAINED AROUND THE SITE TO DRAW IN AS MUCH FRESH AIR AS ALLOWS

6. ENSURE THOSE ENTERING THE MEZZANINE GYM FLOOR MAINTAIN CLEAN HANDS, BY PROVIDING ADDITIONAL HAND SANITISER DISPENSERS AT KEY LOCATIONS AROUND THE FACILITY

7. SIGNAGE AND/OR FLOOR MARKERS WILL BE IN PLACE TO REMIND PEOPLE TO KEEP 2 METERS APART, EMPLOYEES WILL ENFORCE SOCIAL DISTANCING

8. ANY EQUIPMENT WHICH ALLOWS MORE THAN TWO MEMBERS TO USE IT SIMULTANEOUSLY WILL BE LIMITED TO ONE MEMBER (FOR EXAMPLE THE DUAL ASSISTED PULLEY) UNLESS 2 METERS CAN BE MAINTAINED

- 9. AT LEAST ONE CLEANING STATION WILL BE AVAILABLE TO FACILITATE THE CLEAN AS YOU USE SYSTEM IN ADDITION TO EXTRA SIGNAGE AND ANNOUNCEMENTS/D6 SCREEN REMIND MEMBERS TO CLEAN DOWN
- 10. ALL EQUIPMENT INCLUDING RESISTANCE KIT MUST BE 2 METERS APART FROM THE CENTRE POINT OF THE SEAT TO THE CENTRE POINT OF THE SEAT NEAREST. ANY EQUIPMENT WHICH IS NOT 2 METERS AWAY FROM OTHER EQUIPMENT MUST BE TAKEN OUT OF USE
- 11. ONLY WATER FOUNTAINS THAT ALLOW A RECEPTACLE TO BE FILLED WILL BE IN USE WITH SIGNAGE ADVISING CLEAN BEFORE AND AFTER USE. BUBBLER TAPS FOR FACE TO FACE DRINKING SHOULD BE OUT OF USE.
- 12. ANY STAND ALONE WATER OUTLETS OUT OF USE SUCH AS A WATER FOUNTAIN WITH ONLY A BUBBLER TAP MUST BE FLUSHED THROUGH WEEKLY AS PER THE LITTLE USED WATER OUTLET PROCEDURE

**Hazard : COVID-19 TRANSMISSION SPEED FLEX STUDIO** IF THE CONTROL MEASURES ARE NOT FOLLOWED THE RISK OF TRANSMISSION OF COVID-19 COULD BE INCREASED

**Control Measures:**

1. THE SPEED FLEX STUDIO WILL ONLY BE AVAILABLE TO THOSE WHO HAVE PRE-BOOKED AN INDIVIDUAL WORKOUT SPACE. NO GROUP EXERCISE CLASSES WILL BE OPERATED. SEE PIWS RISK ASSESSMENT FOR FURTHER DETAILS
